I have been an APRA member for about 12 years now, and I continue to be happily surprised at our collegiality and community. Several months ago, I had the chance to co-present a session on prospect research to the Southeastern Wisconsin Chapter of AFP with Shawn Perrin, a Milwaukee nonprofit consultant and APRA-Wisconsin member. This invitation from AFP has blossomed into what I hope will be a great collaboration. But I will need your help.

Southeastern Wisconsin AFP is establishing a Professional Development Series: small groups meeting over a few sessions to train in core fundraising practices. AFP regularly surveys its members' interests, and prospect research was recently identified as an interest by more than 46% of its members. When you consider the important role research plays in other topics – from major gifts, to board development, to campaigns, etc. – the interest could be very high indeed. I would like each of you to consider leading one or more of these small groups. You may be surprised to find out just how much you know! I was a teacher in a former life, and I can vouch that there is nothing quite like it for expanding your own skills, knowledge, expertise, and confidence, all at the same time. The sessions will be hands-on, so you will not need to prepare a presentation or PowerPoint. The groups will be small, so you won't need a microphone, and you probably won't even need to stand. It's a great way to get your feet wet in the wonderful world of training and presenting. More importantly, while telling the story of prospect research, you will be providing a great service to our fundraising colleagues, making new personal connections with Milwaukee nonprofits, and falling in love with some of their missions. What might these sessions look like? Well, perhaps you could spend one session showing how you figure out who to research; one on property research; another on small businesses, corporations and foundations; and wrap it up with a bonus session on stocks. That's just one idea. Email me if you are interested or simply curious. Email me with your ideas. We'll also discuss this when we meet later this month!

This is just the first step in what could be a great partnership between APRA and AFP. As I love to say, "Stay tuned!"

Updates from APRA International

Membership

As many of you know, in February I participated in a Chapter Leaders Think Tank in Chicago with other APRA presidents from around the country. It was the first time that APRA brought us all together in the same room (presidents' meetings are conducted via webinars and conference calls). The International board sought chapters' input and ideas as one of the first steps in formulating a new strategic plan for the organization, which might have included some dramatic changes. At our February meeting, everything was on the table.

Fast-forward six months, and at the chapter presidents' meeting during the International Conference earlier this month, it was announced that there will not be any changes to membership rules. Elizabeth Dollhopf-Brown, APRA International President-Elect, stated that APRA will be implementing a "member-centric" model, and will soon be rolling out enhancements to the value of membership for both International and Chapter members. 2012 Salary and Demographic Survey

Highlights of APRA's recent *Salary and Demographic Survey* were announced at the International Conference in Minneapolis. The complete survey results will soon be available on the APRA International website. There were more than 700 responses. Nearly half of the respondents work in a small research shop (one or two researchers), and only 16% work in an organization with nine or more researchers. The most common job titles are "Researcher" and "Director of Research." Nearly half of us have an advanced college degree. The average length of our research careers is eight years, and the average tenure in our current position is five years. The Northeast and Midwest are the two regions with the greatest number of prospect researchers. Over 50% of us report being satisfied in our position, and 37% of us are satisfied with our pay. Many of us are concerned about the lack of growth opportunities, but the good news is that our salaries are trending upwards.
